AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 63.40 RELATING TO SAN DIEGO-LA JOLLA UNDERWATER PARK ECOLOGICAL RESERVE - BOATING REGULATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 3, of the San Diego Municipal Code be and the same is hereby amended by amending Section 63.40 to read as follows:


**SEC. 63.40 SAN DIEGO-LA JOLLA UNDERWATER PARK
ECOLOGICAL RESERVE - BOATING
REGULATIONS**

- a. through e. No Change.
- f. The City Manager shall cause appropriate buoys or markers to be moored to mark the perimeters of the special use and restricted areas hereby designated, or as close thereto as shall be practicable. Between October 1st and April 30th of each year, the City Manager is further authorized to reduce the size of the boating prohibited zone established in subsection c by removing buoys or markers as may be appropriate to accommodate seasonal demands.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

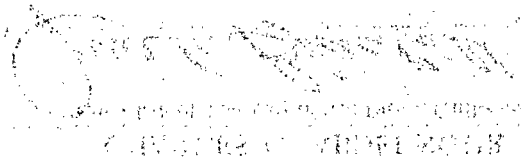

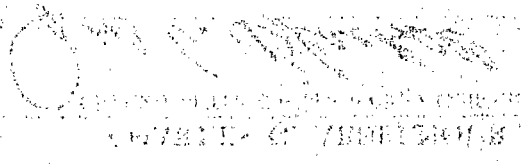

This amends San Diego Municipal Code section 63.40 to provide that within the San Diego-La Jolla Underwater Park the City Manager is authorized, to remove buoys between the period commencing October 1st and April 30th to reduce the size of the no-boating/swimming zone based on seasonal demands.
