AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1,  
DIVISION 5 OF THE SAN DIEGO MUNICIPAL CODE BY  
ADDING SECTION 101.0510(c)2(c) RELATING TO  
CONDITIONAL USE PERMIT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, of the San Diego Municipal Code be and the same is hereby amended by adding section 101.0510(c)2(c) to read as follows:

**SEC. 101.0510 CONDITIONAL USE PERMIT**

A. through B. [No change.]

C. USES WHICH MAY BE CONSIDERED

1. [No change.]

2. Planning Director or Decisionmaker.

a. and b. [No changes.]

c. Living units, subject to the requirements of Section 101.0518.


3. through 6. [No changes.]

D. through Q. [No changes.]

Section 2. This ordinance shall become effective on the thirtieth day following its certification as submitted as a Local Coastal Plan Amendment by the California Coastal Commission. If the ordinance is not certified by the Coastal Commission or is

certified with suggested modifications, this ordinance shall become null and void. No building permits or coastal development permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.


