AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0101.76 RELATING TO SINGLE ROOM OCCUPANCY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, of the San Diego Municipal Code be and the same is hereby amended to read as follows:

SEC. 101.0101.76 SINGLE ROOM OCCUPANCY (SRO)

A unit of 220 net square feet or less within a hotel providing sleeping or living facilities in which sanitary facilities may be provided within the unit and cooking facilities may be shared within the hotel. This definition shall be applicable only to units provided after NOV 1 1989 .

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
