AN ORDINANCE APPROVING A ONE-YEAR EXTENSION OF
TIME TO EMERGENCY ORDINANCE NO. O-17170 (NEW
SERIES)

WHEREAS, on November 1, 1988, the Council of The City of San Diego adopted, for a period of one year, Emergency Ordinance No. O-17170 (New Series) which, inter alia, limits the height and floor area ratio (F.A.R.) of structures in the Harborview, Ash Street Mall, Cortez Hill and core sub-districts of the Centre City San Diego Community; and

WHEREAS, the City Council has initiated the preparation of and intends to adopt an updated community plan for the Centre City San Diego Community; and

WHEREAS, a Centre City San Diego Community Plan is currently being prepared by the Planning Department of The City of San Diego in conjunction with the 26-member Centre City Planning Committee appointed by the Mayor; and

WHEREAS, in order to proceed with the Centre City San Diego Community Plan process, allowing certain project approvals could be inconsistent with the objectives of proposed zoning and urban design legislation to be incorporated into that plan; and

WHEREAS, a one-year extension to Emergency Ordinance No. O-17170 (New Series) is necessary to allow final preparation of the Centre City San Diego Preliminary Plan and Interim Design and Development Ordinance; and


WHEREAS, the Council of The City of San Diego has conducted a public hearing and considered all written reports and oral testimony for a one-year extension of time to Emergency Ordinance No. O-17170 (New Series); NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, that Emergency Ordinance No. O-17170 (New Series) is hereby extended for a period of one year through October 31, 1990, or until the adoption of the Centre City San Diego Plan and the Design and Development Ordinance, whichever first occurs.

BE IT FURTHER ORDAINED, that this ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-17326-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE BUDGET FOR THE ENGINEERING AND DEVELOPMENT DEPARTMENT BY CREATING A NEW TRANSPORTATION MANAGEMENT DIVISION AND ADDING TO THE PERSONNEL AUTHORIZATION OF THE ENGINEERING AND DEVELOPMENT DEPARTMENT (\$40), FOR THE NEWLY CREATED TRANSPORTATION MANAGEMENT DIVISION, TEN AND ONE HALF (10.50) NEW POSITIONS AS FOLLOWS: 1.00 DEPUTY DIRECTOR, 0.50 PRINCIPAL PLANNER, 1.00 SENIOR TRAFFIC ENGINEER, 1.00 SENIOR PLANNER, 1.00 ASSOCIATE TRANSPORTATION PLANNER, 1.00 ASSOCIATE TRAFFIC ENGINEER, 1.00 ASSISTANT TRANSPORTATION PLANNER, 1.00 ASSOCIATE ADMINISTRATIVE ANALYST, 1.00 ASSOCIATE PLANNER, 1.00 SENIOR PUBLIC INFORMATION OFFICER, 1.00 GRAPHIC DESIGNER, 1.00 WORD PROCESSING OPERATIONS, 2.00 CLERICAL ASSISTANTS & ALL FOR THE SOLE AND EXCLUSIVE PURPOSE OF IMPLEMENTING THE CITY OF SAN DIEGO'S TRANSPORTATION DEMAND PROGRAM; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER WITHIN THE GENERAL FUND 100 THE SUM OF \$628,000 FROM NON-DEPARTMENTAL EXPENDITURES (801) TO THE ENGINEERING AND DEVELOPMENT DEPARTMENT (\$40) FOR THE PURPOSE OF FUNDING SAID PROGRAM AND PERSONNEL; EXEMPTING ONE (1) DEPUTY DIRECTOR POSITION FROM THE CLASSIFIED SERVICE.

This ordinance amends the annual appropriation ordinance by adding a new Transportation Demand Management Division consisting of the following positions: 1.00 Deputy Director, 0.50 Principal Planner, 1.00 Senior Traffic Engineer, 1.00 Senior Planner, 1.00 Associate Transportation Planner, 1.00 Associate Traffic Engineer, 1.00 Assistant Transportation Planner, 1.00 Associate Administrative Analyst, 1.00 Associate Planner, 1.00 Senior Public Information Officer, 1.00 Graphic Designer, 1.00 Word Processing Operator, 2.00 Clerical Assistants if positions to the Engineering and Development Department. It also provides an increase in funds to finance Personnel Services \$405,581 and Non-Personnel Services \$220,439, said funds to be obtained from the General Funds.


