AN ORDINANCE INCORPORATING 18,661 SQUARE FEET LOCATED ON THE EAST SIDE OF FRONT STREET BETWEEN WALNUT AVENUE AND UPAS STREET, IN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO MR-1000 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 103.1505, AND REPEALING ORDINANCE NO. 11796 (NEW SERIES), ADOPTED MARCH 3, 1976, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT(S) HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 18,661 square feet, located on the east side of Front Street between Walnut Avenue and Upas Street, in the Uptown Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R1-5000" on Zone Map Drawing No. B-3938, filed in the office of the City Clerk as Document No.0017370, be, and it is hereby incorporated into MR-1000 Zone, as such zone is described and defined by San Diego Municipal Code Section 103.1505

Section 2. That Ordinance No. 11796 (New Series), adopted March 3, 1976, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
