Section 2. That all properties incorporated into the CPIOZ, designated as "Type B" on Zone Map Drawing No. C-771.1, meet Criterion B of Section 101.0457 of the San Diego Municipal Code.

Section 3. That all prior ordinances of The City of San Diego be and they are hereby repealed insofar as they conflict herein.

Section 4. That projects permitted under Planned Development Permits or Conditional Use Permits prior to the effective date of this ordinance may develop in accordance with the provisions of the approved permit; provided, however, that any requested amendments to approved permits shall be subject to the provisions of this ordinance.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, except as provided in Section 4, no building permits for development inconsistent with the provisions of this ordinance shall be issued on or after the date on which this ordinance becomes effective.
