BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-17326-1 and No. OO-17326-2, as amended and adopted therein, by adding to the personnel authorization schedule of the Planning Department (065) Program Element 06533, two (2.00) Senior Planner positions, four (4.00) Associate Planner positions, two (2.00) Junior Planner positions and one (1.00) Clerical Assistant II position, all for the purpose of administering the Landscape Technical Manual.

Section 2. That the Auditor and Comptroller be and he is hereby authorized to increase the Planning Department FY 1990 appropriation and increase the General Fund 100 appropriation and revenue estimates by \$379,272 (Revenue Account 77122) for personnel and nonpersonnel expenses.

Section 3. That the Auditor and Comptroller is hereby further authorized to transfer within the General Fund 100 the sum of \$59,016 from the Unallocated Reserve (605) to the Planning Department (065).

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
