AN ORDINANCE AMENDING ORDINANCE NO. 0-17305 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1989-90" BY AMENDING EXHIBIT B THERETO TO CREATE AND ADD A NEW CLASS ENTITLED "POOL TECHNICIAN SUPERVISOR" IN THE EQUIPMENT MAINTENANCE OCCUPATION GROUP; AMENDING EXHIBIT A-1 OF SAID ORDINANCE TO PROVIDE A NEW SALARY RATE 73.8 FOR SAID POSITION IN THE CLASSIFIED SERVICE, AS SET FORTH IN ATTACHMENT A HERETO; AMENDING RESOLUTION NO. R-273664 TO PLACE THE NEWLY CREATED CLASS IN THE SUPERVISORY REPRESENTATION UNIT; AND AMENDING RESOLUTION NO. R-273663 TO APPROVE AND DECLARE THE ABOVE NEWLY CREATED CLASS AS ELIGIBLE FOR PREMIUM RATE OVERTIME BY PLACING IT IN GROUP B OF SAID OVERTIME ELIGIBILITY RESOLUTION No. R-273663.

WHEREAS, the Park and Recreation Department has requested a new classification to serve as a first level supervisor over the City's swimming pool maintenance function; and

WHEREAS, the duties and responsibilities require a unique combination of mechanical repair skills and knowledge of pool water quality maintenance procedures; and

WHEREAS, duties are many and varied, as set forth with specificity in the Personnel Director's Report to the Mayor and Council, dated September 12, 1989; and

WHEREAS, since there is currently no existing classification which encompasses the duties described above, it is recommended that a new class of Pool Technician Supervisor be created at a salary rate of \$2,230 to \$2,663 per month; and

WHEREAS, this recommended salary range will provide an approximate 15% supervisory differential over the Pool Technician, which is consistent with the City's compensation practices for supervisory classes with similar supervisory responsibilities; and

WHEREAS, it is further recommended that this class be eligible for premium rate overtime under the same conditions as other classes which are listed in Group B of the Addendum to Personnel Manual Section H-4, Overtime; and

WHEREAS, included in this group are those classes designated as exempt from the overtime provisions of the Fair Labor Standards Act but eligible for premium rate overtime in accordance with City policy; and

WHEREAS, it is also recommended that this class be placed in the Supervisory Bargaining Unit; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17305 (NEW SERIES), as amended entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1989-90" be and the same is hereby further amended by amending Exhibit B thereto by creating and adding a new classification, class number 1738, entitled "POOL TECHNICIAN SUPERVISOR" in the Equipment Maintenance Occupational Group at salary rate number 73.8.

Section 2. That Exhibit A-1 of the above cited ordinance be amended to include a new salary rate number 73.8, ranging from

\$2,230 to \$2,663 per month, at rates and steps as set forth in Attachment A hereto.

Section 3. That Resolution No. R-273664 be and it is hereby amended to place the newly created class of POOL TECHNICIAN SUPERVISOR in the Supervisory Representation Unit.

Section 4. That Resolution No. R-273663 be and it is hereby amended by approving and declaring the newly created class as exempt from the Fair Labor Standards Act and eligible for premium rate overtime and placing said newly created class in Group B Overtime Eligibility.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
