AN ORDINANCE AMENDING ORDINANCE NO. 0-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-17326-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING AND ADDING TO THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065) PROGRAM ELEMENT 06532, 0.50 ASSOCIATE PLANNER POSITION AND 0.33 CLERICAL ASSISTANT II POSITION; AUTHORIZING THE AUDITOR AND COMPTROLLER TO INCREASE THE REVENUE ESTIMATES [REVENUE ACCOUNT 71981] AND ALSO INCREASE THE GENERAL FUND 100 APPROPRIATION BY \$23,300 FOR PLANNING DEPARTMENT USE: FURTHER INCREASE THE NON-DEPARTMENTAL EXPENDITURES (100/601) BY \$4,200 FOR OFFICE LEASE SPACE AS A RESULT OF THE 46% COST RECOVERABLE PORTION OF THE PROGRAM; FURTHER AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$33,509 WITHIN THE GENERAL FUND 100 FROM THE UNALLOCATED RESERVE (605) TO THE PLANNING DEPARTMENT (065); AUTHORIZING THE AUDITOR AND COMPTROLLER TO ALLOCATE \$51,931 TO PERSONNEL SERVICES AND \$4,872 TO NON-PERSONNEL EXPENSE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-17326-1, as amended and adopted therein, by adding to the personnel authorization schedule of the Planning Department (065) Program

Element 06532, 0.50 Associate Planner position and 0.33 Clerical Assistant II position.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100, the sum of \$33,509 from the Unallocated Reserve (605) to the Planning Department (065).

Section 3. That the Auditor and Comptroller is further authorized to increase the General Fund 100 appropriation and revenue estimates [Revenue Account 71981] by \$23,300 for allocation to the Planning Department (065).

Section 4. That the Auditor and Comptroller is further authorized to increase the General Fund 100, Non-Departmental (601) appropriation by the sum of \$4,200 from the 46% cost recoverable portion of the program for office lease space.

Section 5. That the Auditor and Comptroller is further authorized to allocate in the Planning Department from the sums enumerated in sections 2 and 3 above the amount of \$51,937 to personnel services and \$4,872 to non-personnel expense [\$3,037 Supplies and Services, \$1,835 Equipment Outlay], for the purpose of fully funding the costs related to administering the Golden Hill Planned District Ordinance.

Section 6. That the expenditure not to exceed the total sum of the above specified funds (\$61,000) be and it is hereby authorized for the purpose of administering the Golden Hill Planned District ordinance.

Section 7. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant

to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

This ordinance amends the annual appropriation ordinance by adding 0.83 positions to the Planning Department (065) (0.50 Associate Planner and 0.33 Cierical Assistant II) for the purpose of administering the Golden Hill Planned District Ordinance (Program Element 06532). The ordinance also increases Revenue Estimates (Revenue Account 71981) and the General Fund 100 by \$23,000 for Department and further increases Non-Departmental expenditures (601) by \$4,200 for office lease space costs, aald monies representing 46% of recoverable costs in the program.

Finally, the ordinance authorizes the Auditor and Comptroller, to transfer \$33,509 from the Unallocated Reserve (605) to the Planning Department (065) and authorizes the allocations of \$51,931 to personnel services and \$4,872 to non-personnel services.
