AN ORDINANCE AMENDING ORDINANCE NO. O-17326 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-17326-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING ONE (1.00) MANAGEMENT ASSISTANT POSITION TO NON-DEPARTMENTAL EXPENDITURES (60100); DIRECTING THE CITY AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$39,647 FROM WATER REVENUE FUND (41502) TO THE GENERAL FUND 100, NON-DEPARTMENTAL EXPENDITURES (60100) AND ALLOCATING SAID \$39,647 TO THE GENERAL FUND 100, NONDEPARTMENTAL EXPENDITURES (60100); AND AUTHORIZING THE EXPENDITURE OF THE SUM TO FUND SAID NEWLY AUTHORIZED POSITION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. O-17326 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-90 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-17326-1, as amended and adopted therein, by adding to the personnel authorization of the General Fund 100, Nondepartmental Expenditures (60100) one (1.00) Management Assistant position for the purpose of coordinating the activities of City departments as they relate to the San Dieguito River Valley Regional Park.

Section 2. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$39,647 from the Unallocated Reserve of the Water Revenue Fund (41502) to the General Fund 100 for the purpose of fully funding such position for the remainder of Fiscal Year 1989-1990.

Section 3. That the City Auditor and Comptroller be and he is hereby directed to increase the General Fund 100 Budget, Non-departmental Expenditures (60100) by the sum of \$39,647 and he is further authorized to expend said sum to fund the newly authorized position.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
