

ORDINANCE NUMBER O- 17387 (NEW SERIES)

ADOPTED ON NOV 14 1989

AN ORDINANCE INCORPORATING VARIOUS PROPERTIES LOCATED WITHIN THE LINDA VISTA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-5000 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 101.0407, IN ORDER TO IMPLEMENT THE SINGLE-FAMILY PROTECTION ORDINANCE, AND REPEALING ORDINANCE NO. 8596 (NEW SERIES), ADOPTED MARCH 18, 1962, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That various properties located within the Linda Vista Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R1-5000" on Zone Map Drawing No. C-790.2, filed in the office of the City Clerk as Document No 00-17387, be, and they are hereby incorporated into the R1-5000 zone, as such zones are described and defined by San Diego Municipal Code Section 101.0407.


Section 2. That Ordinance No. 8596 (New Series), adopted March 18, 1962, of the ordinances of The City of San Diego be and it is repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
