BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, of the San Diego
Municipal Code be and the same is hereby amended by renumbering
and retitling Section 22.0210.1 as follows:

SEC. 22.0211 PUBLIC WORKS CONTRACTS - PUBLIC BIDDING REQUIRED
[No change in text.]

Section 2. That Chapter II, Article 2, of the San Diego Municipal Code be and the same is hereby amended by renumbering, retitling and amending Section 22.0210.2 to read as follows:

## SEC. 22.0212 PUBLIC WORKS - USE OF CITY FORCES

City forces shall not be used on public works projects if the cost therefor exceeds the sum of \$15,000 unless the same shall have first been approved by the Council upon recommendation of the City Manager. When such Council approval is required, the City Manager shall indicate justification for the use of City forces and shall indicate whether the work can be done by City

forces more economically than if let by contract. The City Manager may exercise his discretion on the use of City forces on public works projects when the cost therefor does not exceed the amount of \$15,000.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
