ORDINANCE NUMBER O- 17895 (NEW SERIES)

ADOPTED ON DEC 4 1989

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0501 ALLOWING FOR THE APPOINTMENT OF AN ALTERNATE MEMBER ON THE BOARD OF ZONING APPEALS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5, of the San Diego Municipal Code be and the same is hereby amended by amending Section 101.0501, to read as follows:

SEC. 101.0501 Board of Zoning Appeals

A. CREATION OF MEMBERSHIP

There is hereby created a Board of Zoning Appeals which shall consist of five members and a designated alternate, who shall serve without compensation. The members and alternate shall be appointed by the Mayor and confirmed by the Council. The members shall serve two year terms and each member shall serve until his successor is duly appointed and qualified. The members shall be appointed in such a manner that the terms of not more than three members shall expire in any year. The expiration date shall be March 1. During March of each year the Mayor shall designate one member as chairman; however, in the absence of such designation, the Board shall on or after April 15 select from among

its members a chairman. The alternate shall serve only in the event of an absence of a Board Member and may not be designated or selected as chairman. In the event of a resignation of a member, the alternate shall serve until a new member is appointed by the Mayor.

B. MEETINGS


The Board shall meet regularly once a month or as often as necessary for the transaction of business. It shall establish its own rules and procedures necessary or convenient for the conduct of its business.

Three members of the Board of Zoning Appeals shall constitute a quorum. The affirmative vote of not less than three members shall be necessary for any action by the Board.

Section 2. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage.



BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5, of the San Diego Municipal Code be and the same is hereby amended by amending Section 101.0501, to read as follows:

SEC. 101.0501 Board of Zoning Appeals

A. CREATION OF MEMBERSHIP

Allows for the appointment of five members and a designated alternate with said appointment to be made by the Mayor and confirmed by the City Council. The designated alternate shall only serve in the event of an absence of a Board Member and may not be designated or selected as chairman.

B. MEETINGS

The Board shall meet once a month or as often as necessary for the transaction of business.

Section 2. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its passage.
