AN ORDINANCE AMENDING ORDINANCE NO. O-17326 ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1989-1990 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY INCREASING THE CAPITAL IMPROVEMENTS PROGRAM BY ADDING \$78,900 IN CIP 22-031.2 SAIL (CRESCENT) BAY - DEVELOPMENT, PHASE III.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-17326, as amended, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 1989-1990 and Appropriating the Necessary Money to Operate the City for Said Fiscal Year" is hereby amended to increase the Capital Improvements Program by adding \$78,900 to CIP No. 22-031.2 SAIL (CRESCENT) BAY - DEVELOPMENT, PHASE III.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
