BE IT RESOLVED, by the Council of The City of San Diego, that the week of January 9 through 15, 1989 be recognized by the citizens of San Diego as a time to join with people throughout the world in expressions of compassion and caring for the earthquake survivors, and in offers of support for the emergency relief efforts now underway, including those of the Armenian Relief Society's Earthquake Fund, P.O. Box 409, Watertown, MA 02272.
