BE IT RESOLVED, by the Council of The City of San Diego that the low bid of CASA VERDE LANDSCAPE, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF KEARNY MESA PARK as may be required for a period of one (1) year beginning January 1, 1989 through December 31, 1989, at a cost of \$2,960.00 per month for a total estimated cost of \$35,520.00 per year; terms net 30 days; with options to renew contract for four (4) additional one (1) year periods, with price escalations not to exceed 10% of prices in effect at the end of each prior year.

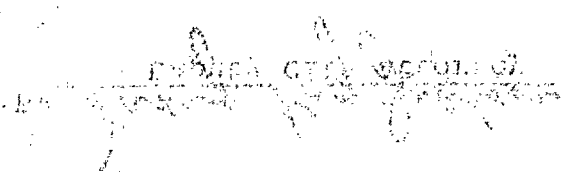

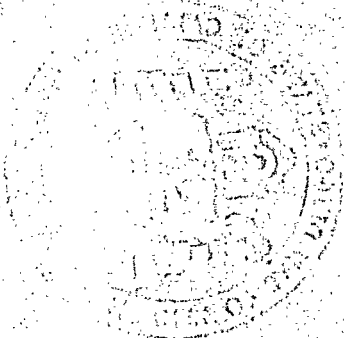
