BE IT RESOLVED, by the Council of The City of San Diego that the low bid of GELCO SPACE, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for LEASE OF ONE 24 FT. X 60 FT. OFFICE TRAILER FOR PT. LOMA WASTEWATER TREATMENT PLANT as may be required for a period of one (1) year beginning approximately, February 1, 1989 through January 31, 1990, at a cost of \$710.00 per month, for a total cost of \$8,520.00 per year; terms net 30 days, plus sales tax; plus a delivery charge of \$623.00, set-up charge of \$3,141.00, return charge of \$623.00, and tear-down charge of \$539.00; with options to renew the lease for two (2) additional one (1) year periods or to buy out the trailer at the end of each lease year, per prices on file in the Purchasing Department.

BE IT FURTHER RESOLVED, that in the event the City is unable to negotiate satisfactory lease terms and conditions with the low bidder, the City Manager is hereby authorized to execute a contract with the second low bidder, SPACE MASTER INTERNATIONAL, INC. at a cost of \$831.00 per month, plus delivery, set-up, return and tear-down charges totalling \$4,738.00.

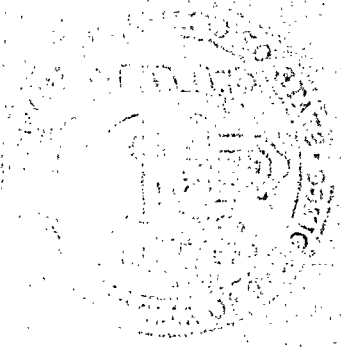
