BE IT RESOLVED, by the Council of the City of San Diego that the revised plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF ALVARADO REGULATING RESERVOIR ROOF, PHASE I: 42-INCH BY-PASS SYSTEM, filed in the office of the City Clerk of the City of San Diego, California, on JAN 9 1989, and bearing official Document No. W.O. 180001, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF ALVARADO REGULATING RESERVOIR ROOF, PHASE I: 42-INCH BY-PASS SYSTEM, in accordance with the specifications.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$33,189 from the Water Revenue Fund 41502, CIP No. 73-235 ALVARADO REGULATING RESERVOIR ROOF, to supplement funds previously authorized by Resolution No. 267573, adopted on February 2, 1987, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
