WHEREAS, two propositions pertaining to the growth initiative in The City of San Diego were included on the ballot of the November 8, 1988 election; and

WHEREAS, since these propositions failed, a research study was conducted as a guide to the City for future growth initiatives; and

WHEREAS, the overall objectives of the research study was to determine the attitudes of residents of The City of San Diego, who voted in the November 8th election, toward the growth initiatives, as well as the reasons for their attitudes; and

WHEREAS, in order to expedite the completion of the study, funds were expended from the City Manager's budget, and since the expense is unbudgeted, this request is to reimburse the City Manager's office for the cost to conduct the study; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby fully authorized to transfer the sum of \$15,531 within the General Fund 100 from

the Unallocated Reserve (605) to the City Manager's Department  
(040) for reimbursement of the costs incurred to conduct a study  
of voter opinions on growth management.
