WHEREAS, the Memorial will honor slain police officers throughout the nation; and



BE IT RESOLVED, by the Council of The City of San Diego, that the provisions of Paragraph VI, subparagraph B, of Council Policy 300-6, Employee-Employer Relations, and Article 36, Payroll Deduction, of the current Memorandum of Understanding between The City of San Diego and the San Diego Police Officers Association, limiting payroll deductions for employee organizations to membership dues and insurance payments, are hereby waived for the specific purpose of authorizing members of the San Diego Police Officers Association to contribute to the construction of a

National Police Memorial through two (2) special pay period
payroll deductions of \$2.50 per pay period.

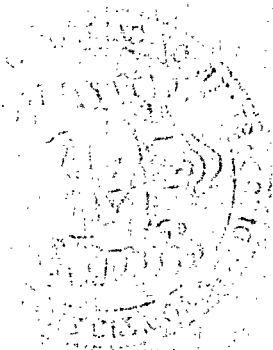
