WHEREAS, Dr. King, through word and deed, inspired us to perfect the principles of freedom, justice and equality upon which our great nation was founded; and

WHEREAS, the Civil Rights Act of 1964 and the Voting rights Act of 1965 were achieved, in large part, by the efforts of Dr. King to convince America to abide by its most cherished ideals and apply them equally to all citizens; and

WHEREAS, the life and sacrifice of Martin Luther King Jr. should be remembered and revered by present and future generations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of The City of San Diego and its people, do hereby recognize and observe the third Monday in January of 1989 to be "Dr. Martin Luther King Jr. Day" as set forth in section 21.04 of the San Diego Municipal Code, in honor

and recognition of Dr. King's lasting imprint on our City, State
and our Nation.
