BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of \$115,837.80 by DRAINAGE CONSTRUCTION CO., INC. a corporation, meeting specifications for THE RECONSTRUCTION OF ELLIOTT STREET STORM DRAIN, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 119173.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$31,000 from CIP No. 17-001 ANNUAL ALLOCATION - MINOR DRAIN IMPROVEMENTS to CIP No. 17-101.4 RECONSTRUCTION OF ELLIOTT STREET STORM DRAIN.

3. That the expenditure, not to exceed \$31,000 from CIP No. 17-101.4 RECONSTRUCTION OF ELLIOTT STREET STORM DRAIN, to supplement funds previously authorized by Resolution No. 272125, adopted on October 24, 1988, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
