BE IT RESOLVED, by the Council of The City of San Diego that the low bid of UNIVERSITY FORD, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of POLICE PATROL CARS; one hundred four (104) 1989 Ford Crown Victoria "S" at a cost of \$13,393.04 each and three (3) 1989 Ford Crown Victoria "S" with power windows at a cost of \$13,724.04 each; for a total combined cost of \$1,434,048.28; terms 4% 20 days plus sales tax, less trade-in allowances as follows:
