RESOLUTION NUMBER R- 272671

APPROVING MAP OF CARMEL MOUNTAIN RANCH UNIT  
NO. 16C.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Jack L. Osborn, Registered Civil Engineer, entitled "CARMEL MOUNTAIN RANCH UNIT NO. 16C being a subdivision of a portion of Pompeii Farms Company, Pompeii Subdivision, according to Map thereof No. 1738, filed in the office of the County Recorder of San Diego County, September 19, 1922, approval of said Map revoked per City Council Resolution No. 203923, adopted October 12, 1971, in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following:

Cedarhurst Lane, Breezeway Place and Seaglass Court, and said streets are hereby declared to be public streets, and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon or across all of Lot 39, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as well as the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the County Recorder of the County of San Diego, California.
