WHEREAS, the four (4) passenger elevators at Jack Murphy Stadium are over twenty-one (21) years old; and

WHEREAS, the dispatch control system and door operating devices need to be replaced to avoid future, more costly repairs, in addition to providing better service to the public; and

WHEREAS, the interiors of the elevators are also in need of repair; and

WHEREAS, the entire renovation project was originally scheduled to be done in two (2) phases, with the first phase being repair of the elevator interior and the second phase being replacement of the above-mentioned elevator hardware; and

WHEREAS, it is now believed that it would be more cost effective and beneficial to perform the complete renovation work at one (1) time and under one (1) contract; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that C.I.P. No. 34-110.0, SAN DIEGO JACK MURPHY STADIUM ELEVATOR RENOVATION PROJECT, be established with the actual work to be performed in FY 1990.

BE IT FURTHER RESOLVED, by the City Council, that it authorizes the transfer of one hundred thousand dollars (\$100,000.00) from Fund 10330, C.I.P. No. 34-200.0, ANNUAL ALLOCATION-SAN DIEGO JACK MURPHY STADIUM and two hundred and two thousand dollars (\$202,000.00) from Fund 10330, SAN DIEGO JACK

MURPHY STADIUM OPERATIONS FUND, to C.I.P. No. 34-110.0, SAN DIEGO
JACK MURPHY ELEVATOR RENOVATION PROJECT.
