BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, the First Amendment to the Agreement of October 27, 1987 with WILDAN ASSOCIATES pursuant to Resolution No. R-269564, to provide additional funding to extend the existing contract for providing traffic engineering consulting services, as needed, for the Water Utilities Department, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 272692 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$25,000 from the Water Operating Fund, No. 41500, Water Operation Engineering Program, No. 70830, and an amount not to exceed \$25,000 from the Sewer Revenue Fund, No. 41506, Sewer Operation Engineering Program, No. 70820, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
