WHEREAS, during 1988 the Water Utilities Department management in the Metropolitan Wastewater Division (Point Loma Treatment Plant) and the Systems Division received reliable information that illegal drug and narcotic sales and related criminal activity were occurring at City work sites during work hours; and

WHEREAS, since these divisions perform critical functions affecting the public health and safety, an immediate undercover investigation to protect the public health and safety was necessary; and

WHEREAS, in response to these facts, the City Manager's

Office entered into a letter agreement with IBEX Company

(Narcorp) for investigative services, initially estimated to cost

less than \$25,000.00; and

WHEREAS, as the investigation proceeded, it became significantly more complicated and extensive than initially estimated and exceeded \$25,000.00 in actual costs; and

WHEREAS, Municipal Code section 22.0504 authorizes the City Manager to enter into contracts for more than \$25,000.00 in the case of a bona fide emergency affecting public health or safety; and

WHEREAS, the full investigation required the incurrence of \$85,000.00 in professional investigative expenses; and

WHEREAS, Section 22.0504 requires the City Manager to report such expenditures of funds to the City Council for ratification; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of a sum not to exceed \$85,000.00 from the Sewer Revenue Fund (41506) for the purpose of conducting a full and complete investigation by IBEX Company (Narcorp) under those terms and conditions set forth in the letter agreement with Narcorp on file in the office of the City Clerk as Document No.  $\begin{array}{c} RR- & 272694 \\ \hline \end{array} \hspace{0.5cm} \text{, be and the same is hereby ratified and approved.}$
