WHEREAS, Jack McKeon has enjoyed a long and distinguished career in the sport of professional baseball spanning over forty years; and

WHEREAS, Jack McKeon was born in South Amboy, New Jersey and received his education at Seton Hall and Elon College before signing with Pittsburgh in 1949 where he spent ten seasons in the minor leagues; and

WHEREAS, Jack McKeon first began managing in 1955 at the young age of twenty-four as a player/coach and has since served in a variety of roles in professional baseball; and

WHEREAS, Jack McKeon has been with the San Diego Padres since 1979 and has been the Director of Baseball Operations since 1980 where his keen insight and ability to make sound acquisitions earned him the title of "Trader Jack" and served to catapult the Padres into pennant contention in the National League Western Division; and

WHEREAS, on May 28, 1988, Jack McKeon became the 12th manager in Padres' history and lead the Padres, from that point, to the best record in the National League; and


WHEREAS, Jack McKeon is an active member in the community by serving in a number of capacities that enhance the quality of life in San Diego; NOW, THEREFORE,
