BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Larry A. Hibner, Registered Civil Engineer, entitled "CARMEL VALLEY NEIGHBORHOOD 1 UNIT NO. 11 being a subdivision of Parcels 3 and 4 of Parcel Map No. 15370, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, September 15, 1988, as File No. 88-464705 of official records," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Carmel Creek Road, Camino Sandoval, Calle de la Siena and Plaza de la Siena, and said streets are hereby declared to be public streets, and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in Paragraphs 1 and 2 of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; that those easements listed in Paragraphs 1 and 2 of the Owner's Certificate, as granted and shown on this map, are are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
