RESOLUTION NUMBER R- 272716

ADOPTED ON JAN 23 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of CROW-HAZARD ASSOCIATES, a California general partnership, executed in favor of The City of San Diego, bearing dates of July 25, 1988, and August 1, 1988, a copy of which deed is on file in the office of the City Clerk as Document No. RR-272716;/ granting to said City an easement for public street purposes in a portion of Lot 4 of Hazard Center, Map No. 11949, and relinquishing certain abutter's rights of access, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same are hereby named FRIARS ROAD and FRAZEE ROAD.


BE IT FURTHER RESOLVED, that the exchange of abutter's rights of access in and to Friars Road, affecting Lot 4 of Hazard Center, Map No. 11949, which the City Manager has determined to be equal in value, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-272716-2, effecting the revestment of those abutter's rights of access in and to Friars Road, adjacent and contiguous to Lot 4 of Hazard Center,

Map No. 11949, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk shall cause both deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
