RESOLUTION NUMBER R- 272717

ADOPTED ON JAN 23 1989

WHEREAS, The City of San Diego is the owner of a portion of Lot 29, Lemon Villa, Map 734; and

WHEREAS, the City desires to negotiate the sale of said land to JUNG NGOON TOM, trustee under that certain trust agreement dated December 27, 1984, under the provisions of Section 22.0902 of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by outside fee appraiser and reviewed by staff, is THIRTEEN THOUSAND DOLLARS (\$13,000); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No. RR- 272717, be, and the same is hereby authorized to be sold by negotiation for the amount of THIRTEEN THOUSAND DOLLARS (\$13,000) to JUNG NGOON TOM.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 272717, granting to JUNG NGOON TOM all that portion of Lot 29, Lemon Villa, Map 734, as more particularly described in the grant deed.

3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

4. That the City Clerk is hereby authorized and directed to deliver the grant deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.

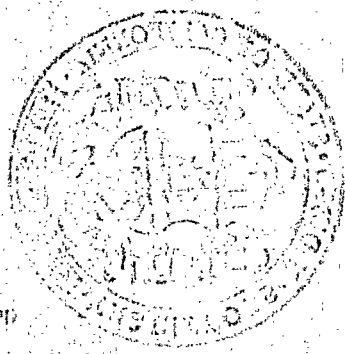
