RESOLUTION NUMBER R- 272719

ADOPTED ON JAN 23 1989

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where for a period of five (5) consecutive years the street or highway has been impassable for vehicular travel and no money was expended for maintenance on the street or highway during such period; and

WHEREAS, the abutting property owners have requested the vacation of Rachael Avenue north of Alleghany Street adjacent to Lot 1 of Bjornson and Myers Subdivision, Map 3817, to facilitate development of their properties; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Rachael Avenue north of Alleghany Street and adjacent to Lot 1 of Bjornson and Myers Subdivision, Map 3817, as more particularly shown on Drawing No. 17342-B, on file in the office of the City Clerk as Document No. RR- 272719-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, along with the incorporated drawings, attested by him under seal, to be recorded in the office of the County Recorder.

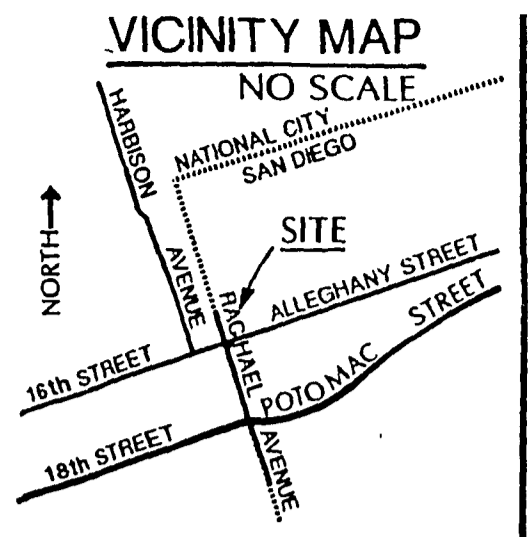
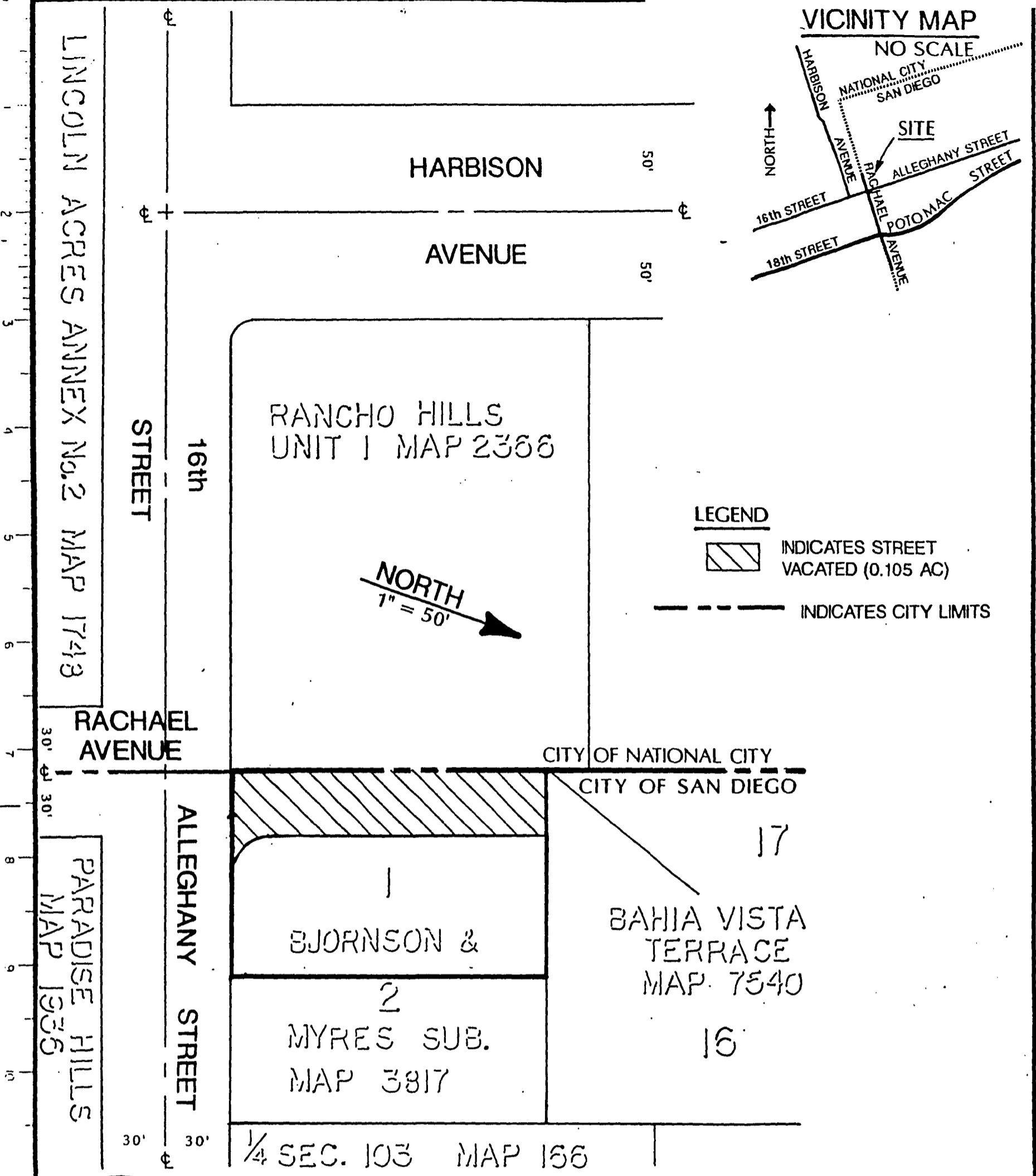

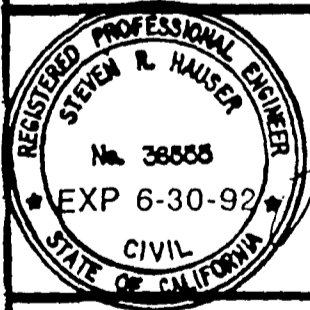
