
RESOLUTION NUMBER R- 272726

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a ten (10)-year lease agreement with BEACH AREA COMMUNITY CLINIC, a California nonprofit corporation, for the operation and management of a community health center at 3690 Mission Boulevard, providing community AIDS educational services and counseling, at an initial monthly rent of \$100, with a specific right by either party to terminate the lease at any time without cause by giving ninety (90) days notice of intent to so terminate, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 272726.

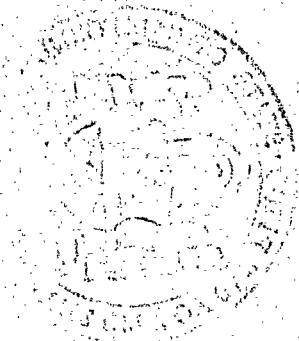
