RESOLUTION NUMBER R- 272744

ADOPTED ON JAN 23 1989

WHEREAS, AB 4521 (Hannigan) was introduced during the 1988 legislative session and would have required cities and counties to earmark revenues from any new or increased Transient Occupancy Tax (TOT) for certain tourism and convention programs; and

WHEREAS, AB 4521 was referred to interim hearing for further study and has been scheduled for January 23, 1989; and

WHEREAS, Council Policy 000-19 states that it is the "legislative policy of the Council to oppose efforts which allow the state or federal government to preempt those rights to levy taxes as authorized by the California Constitution and the Charter of The City of San Diego;" and

WHEREAS, the Intergovernmental Relations Department (IRD) Report No. 89-4, dated January 11, 1989, recommends that the City Manager be directed to prepare testimony opposing AB 4521 and other restrictions on TOT for presentation at the January 23, 1989 interim hearing; and


WHEREAS, on January 18, 1989, the Rules Committee reviewed the recommendation set forth in IRD Report No. 89-4 and approved it unanimously; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to prepare testimony opposing AB 4521 (Hannigan) and other restrictions on

transient occupancy taxes, for presentation at the January 23,
1989 interim hearing in Sacramento, California.

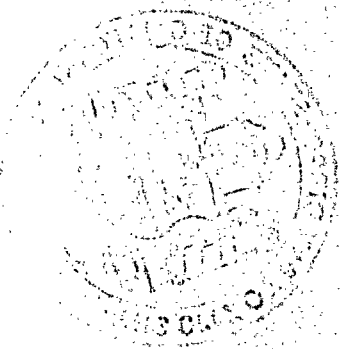
