Alfred Allen	Fire Department	\$320.00	Mr. Allen is a Firefighter. He suggested using red tape with "Danger - Do Not Enter" printed on it to barricade hazard areas at emergency scenes. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Robert Tobias	Water Utilities	\$160.00	Mr. Tobias is a Waste Water Plant Operator with the Metro Division. He suggested installing a two way communication system from the Control Room to the Electronic Technician Trailer. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Gary Redwine	Water Utilities	\$ 90.00	Mr. Redwine is a Waste Water Plant Operator with the Water Production Division. He suggested purchasing battery powered emergency lights for the staff trailer at the Aqua Culture Plant. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Pedro Moreno	City Clerks	\$ 45.00	Mr. Moreno is a Deputy City Clerk. He suggested providing maps giving directions from City Clerk's Office to various departments within the City Operations Building. Although savings are difficult to identify, this was considered to be a significant operational improvement.
