ADOPTED ON JAN 30 1989


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to accept a grant deed, on standard City form, to be subsequently executed by the CITY OF ESCONDIDO, conveying to The City of San Diego an undivided one-half interest in a portion of Oak's Tract in Rancho San Bernardo.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$214,750 from the sale proceeds of First American Title Insurance Company, Escrow 965041 TE, for the above described acquisition, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that this approval is unconditional with the understanding, however, that it is the intention of the City of Escondido to build the clubhouse on either the Townsend parcel or on other property shown within the boundaries described on Attachment A to this resolution, which attachment is by this reference incorporated herein.

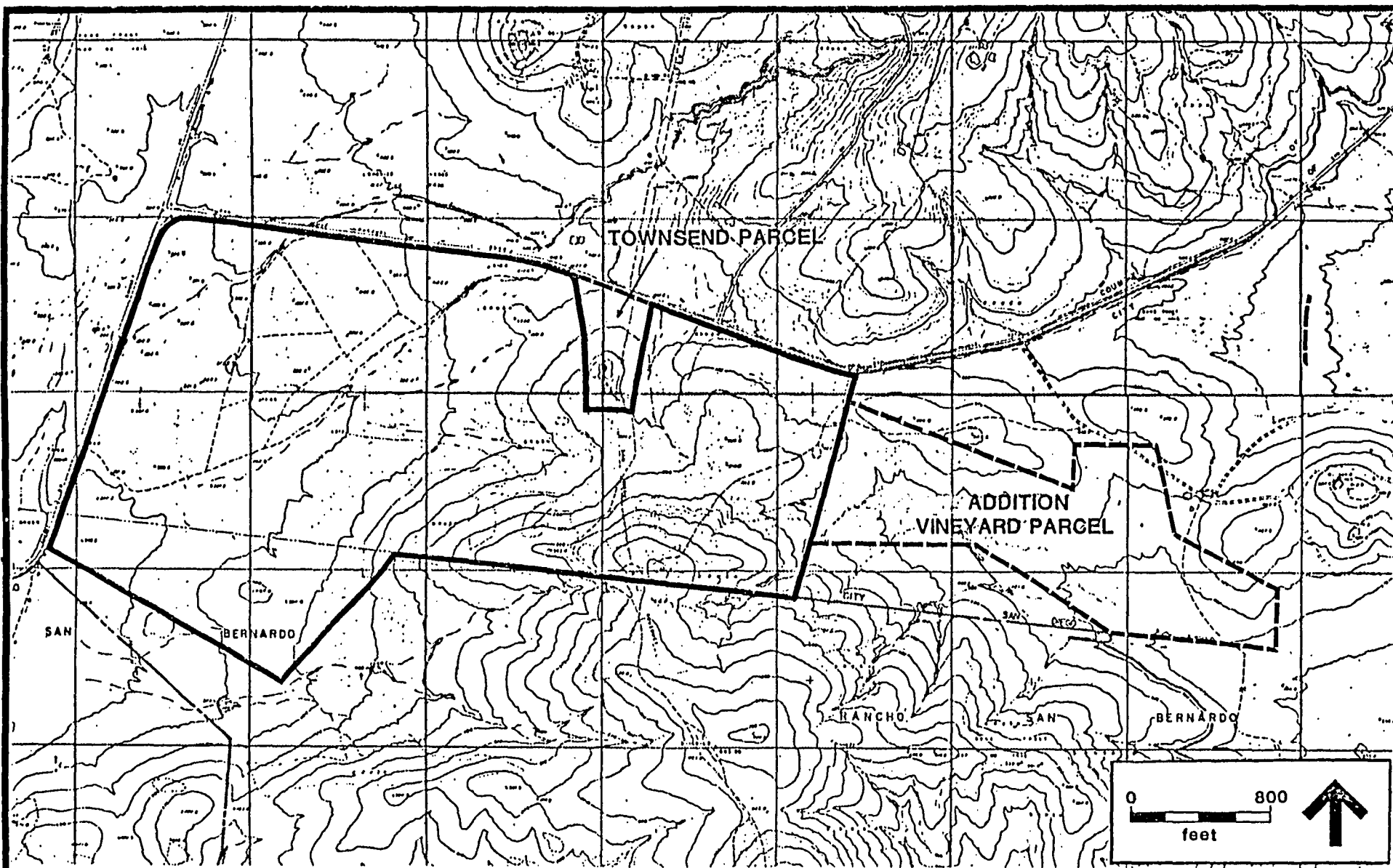
