
RESOLUTION NUMBER R-272799

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to amend Schedule A of the Interim Development Ordinance to reflect the Planning Department's recommendation for a Phase Out Program which would allow the first month of a three-month phase out period for the sixth period allocated projects, and the following two months for the IDO pipeline (backlog) projects, with a limitation of 2,000 units per month, exempting the development agreements in the past six months, as set forth in City Planning Department Report No. 89-038, page 5, under "Recommended Phase Out Program," said report is on file in the Office of the City Clerk as Document No. RR- 272799 .

BE IT FURTHER RESOLVED, that the Planning Department staff is hereby directed to proceed with the phase out program.

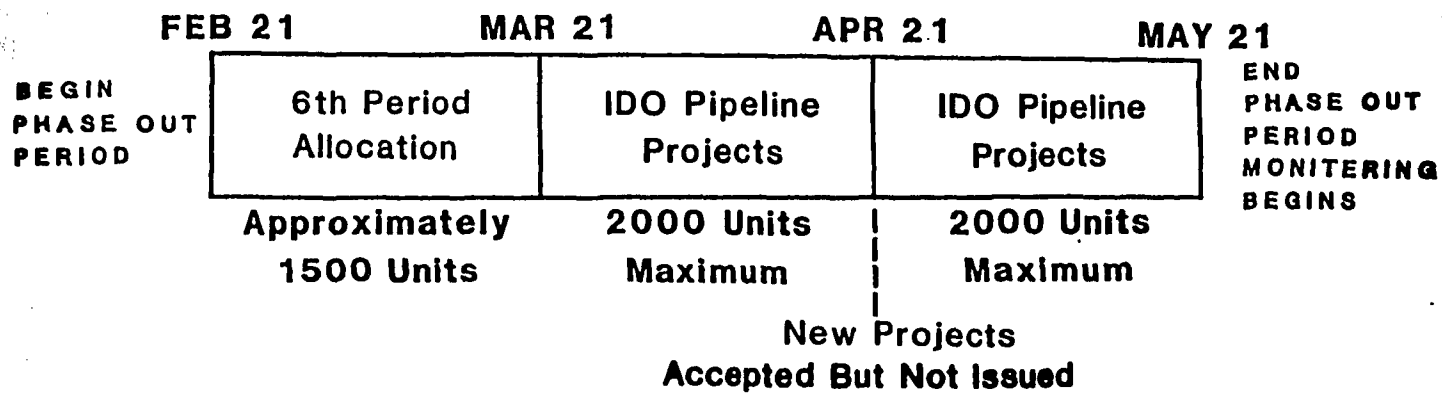
