

RESOLUTION NUMBER R-272802

ADOPTED ON FEB 6 1989

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. GEORGE CHEVROLET, 2. REYNOLDS BUICK GMC, 3. MIRAMAR FORD TRUCK SALES, INC., 4. GMC TRUCK & COACH OPERATION (Oakland), 5. DION INTERNATIONAL TRUCKS, INC., 6. GMC TRUCK & BUS GROUP, GENERAL MOTORS CORPORATION, 7. PACIFIC FREIGHTLINER TRUCKS, and 8. LOS ANGELES FREIGHTLINER - GMC TRUCKS, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MEDIUM AND HEAVY DUTY VEHICLES, as follows:

1. GEORGE CHEVROLET for Item 1 - five (5) each Dump Truck, 3 cubic yard (Chevrolet C7D042 with dump body and hoist) at a cost of \$22,624.00 each; Item 2 - two (2) each Truck Tractors (Chevrolet C7D042 with 5th wheel) at a cost of \$22,295.00 each; Item 4 - eight (8) each Cab and Chassis - 102" CA, 24,000 lb. GVW (Chevrolet C7D042) at a cost of \$17,234.00 each; Item 10 - two (2) each Cab and Chassis 14,000 lb. GVW (Chevrolet C6D042 Lo Pro) at a cost of \$15,604.00; Item 11 - one (1) each Cab and Chassis - 114" CA, 24,000 lb. GVW (Chevrolet C7D042 with PTO) at a cost of \$18,490.00; Item 12 - eight (8) each Cab and Chassis - 84" CA, 22,000 lb. GVW (Chevrolet C7D042 with PTO) at a cost of \$18,364.00 each; and Item 13 - seven (7) each Cab and Chassis - 84" CA, 24,000 lb. GVW (Chevrolet C7D042 with PTO) at a cost of \$18,423.00 each; for a total combined cost of \$621,153.00; terms net 30 days, plus sales tax.
