WHEREAS, the John F. Kennedy School of Government at Harvard University and the Ford Foundation administer the Innovations Award program; and

WHEREAS, the purpose of this award is to recognize exemplary new programs and policies which address important social and economic issues; and

WHEREAS, an application for an Innovations Award was submitted by The City of San Diego on December 16, 1987 with a secondary application submitted on March 25, 1988; and

WHEREAS, on July 5, 1988, The City of San Diego was notified that the Single Room Occupancy Hotel Program was selected as a 1988 Innovations Award recipient; and

WHEREAS, the award carries with it a one-time grant of \$100,000 to help disseminate the program to other jurisdictions;  
NOW, THEREFORE,



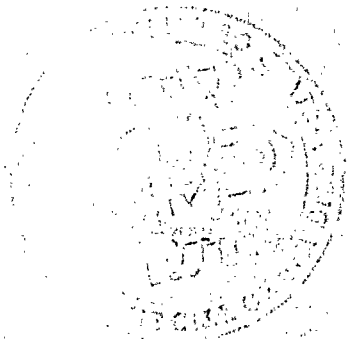
