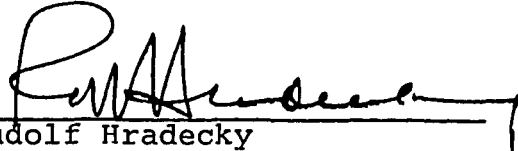

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$500,000 from Park North-East Park Development Fund No. 39095 to CIP No. 29-662, North Park Community Park - Improvements.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$103,300 from CIP No. 29-662, North Park Community Park - Improvements, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and further authorizing the City Auditor and

Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
