BE IT FURTHER RESOLVED, that an increase of \$65,000 for consultant services for the Fifth Amendment is hereby authorized with \$45,200 from FSDRIP, Fund 79364, and \$19,800 from the Sewer Revenue Fund (41506).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$45,200 from FSDRIP, Fund 79364, and \$19,800 from the Sewer Revenue Fund (41506), is hereby authorized, solely and exclusively for the purpose of providing funds for this Fifth Amendment.
