WHEREAS, there exists in the City of San Diego a need for standard housing units affordable to lower income families; and

WHEREAS, The City of San Diego has recognized this and undertaken programs to help meet this need; and

WHEREAS, federal funds in the amount of \$881,000 have been available to The City of San Diego to rehabilitate rental properties in order to increase the supply of standard housing affordable to lower income families; and


WHEREAS, the San Diego Housing Commission is currently implementing a program designed to rehabilitate rental units for the specified purpose and said additional funding for the program has been allocated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council approves and authorizes the City Manager to execute the Rental Rehabilitation Program Application and Description, a copy of which is on file in the office of the City Clerk as Document No. RR-272820-1.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a Memorandum of Understanding with the Housing Commission under the terms and conditions set forth in that memorandum on file in the office of the City Clerk as Document No. RR-272820-2, and that the implementation of the Rental Rehabilitation Program, in accordance with federal

requirements and guidelines is hereby delegated to the Housing
Commission.
