RESOLUTION NUMBER R- 272825

ADOPTED ON FEB 6 1989

WHEREAS, there is no provision in present law to regulate the manufacture, sale or possession of semiautomatic assault weapons and the current penalty for using an assault weapon in the commission of a crime is a minimum two year prison sentence; and

WHEREAS, SB 292 (Roberti) was recently introduced and would make it a felony with an additional five years imprisonment for any person who uses an assault weapon in the commission or attempted commission of a felony crime, would make it a felony for a person or business to manufacture or import assault weapons in California, would establish a procedure for the registration of assault weapons by the Department of Justice and would create the Assault Weapons Commission to determine whether particular firearms are assault weapons; and


WHEREAS, AB 376 (Klehs) was recently introduced and would prohibit the sale and ownership of all assault weapons in California, would require life imprisonment for those convicted of assaulting anyone with such weapons, and would impose a maximum five year prison term for anyone who illegally owns an assault weapon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the recommendations to support SB 292 (Roberti) and AB 376 (Klehs), as well as other legislation regulating the possession and sale of semiautomatic weapons, as set forth in

Intergovernmental Relations Department Report No. 89-10, dated  
January 31, 1989 be and the same are hereby approved.
