BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby initiates the following amendments to the Tierrasanta Community Plan:


1. Tierrasanta Gateway site. The entire site is to be considered for designation for mixed specialized commercial use, providing for office, retail and church use.

2. La Cuenta and Baroque Lane site. The site is to be considered for medical offices.

BE IT FURTHER RESOLVED, that the Planning Commission is directed to conduct a public hearing at which it will consider the amendments and make a recommendation to the City Council.

BE IT FURTHER RESOLVED, that the provisions of Council Policy 600-35 relating to consolidation of hearings on community plan amendments shall not apply to these amendments.
