
RESOLUTION NUMBER R- 272833

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby initiates an amendment to the Otay Mesa Community Plan to designate 198.6 acres immediately west of Brown Field from residential and open space to industrial and open space; portions of the Northwest, Southwest and Southeast Quarters of Section 29, and a portion of Northeast Quarter of Section 32, Township 18 South, Range 1 West.

BE IT FURTHER RESOLVED, that the City Council requests that the Planning Commission exempt the amendment from the hearing consolidation provisions of Council Policy 600-35.B.
