BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF METRO PUMP STATION NO. 1 - STORAGE BUILDING AND EQUIPMENT SHOP, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on FEB 13 1989, and bearing official Document No. 110 170031, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF METRO PUMP STATION NO. 1 - STORAGE BUILDING AND EQUIPMENT SHOP.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$45,300 within the Sewer Revenue Fund 41506 from the Unallocated Reserve 70697 to the Metropolitan Wastewater Construction Program 70292, CIP No. 46-107 METRO PUMP STATION NO. 1 - STORAGE BUILDING AND EQUIPMENT SHOP.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$293,000 from Sewer Revenue Fund 41506, CIP No. 46-107 METRO PUMP STATION NO. 1 - STORAGE BUILDING AND EQUIPMENT SHOP is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
