

RESOLUTION NUMBER R- 272854

ADOPTED ON FEB 13 1989

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for STANDLEY COMMUNITY PARK ADDITIONAL IMPROVEMENTS, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on FEB 13 1989, and bearing official Document No. WD 118896, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for STANDLEY COMMUNITY PARK ADDITIONAL IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$187,700 (\$6,903 from PSD Fund No. 11470, \$53,797 from PSD Fund No. 13400, \$127,000 from Standley Park Assessment District Fund No. 79150 and any additional revenue in this fund in lieu of other funds) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
