
ADOPTED ON FEBRUARY 13, 1989

- 4) Texas Street - Camino Del Rio South to Madison Avenue;
- 5) Napa Street from Linda Vista Road to Morena Boulevard;
- 6) Whittier Street;
- 7) Friars Road Bridge over San Diego River;
- 8) Jackson Drive Extension;
- 9) Genesee Avenue - Linda Vista Road to Osler Street;
- 10) Clairemont Mesa Boulevard Extension;
- 11) Beyer Boulevard - SR 117 to North City limits;
- 12) Sorrento Valley Road - Industrial Court to Carmel Valley Road.
