WHEREAS, severe injury accidents involving unhelmeted motorcycles have an adverse financial impact on local agencies and their taxpayers, and have cost government agencies and taxpayers an excessive amount of money for emergency responses, hospital care and the payment of liability claims; and


WHEREAS, AB 8 (Floyd) and AB 55 (Hansen) seek to improve motorcycle safety and reduce injuries and fatalities through mandatory helmet laws and motorcycle safety training; and

WHEREAS, the Rules Committee, on February 1, 1989, reviewed IRD Report No. 89-9, dated January 26, 1989, and approved the recommendations set forth therein relating to support for AB 8 and AB 55 by a 5-0 vote with the Chair absent; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that recommendations to support AB 8 (Floyd) and AB 55 (Hansen), as set forth in Intergovernmental Relations Department Report No. 89-9, be and the same are hereby approved.
