


RESOLUTION NUMBER R- 272886

BE IT RESOLVED, by the Council of The City of San Diego that the low and low acceptable bids of 1. CALOLYMPIC GLOVE & SAFETY CO., INC., 2. APOLLO INDUSTRIES, 3. BOSS MFG. COMPANY, and 4. R.J. SAFETY SUPPLY CO., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of RAINGEAR AND BOOTS as may be required for a period of one (1) year beginning February 1, 1989 through January 31, 1990, per prices on file in the Purchasing Department, as follows:

1. CALOLYMPIC GLOVE & SAFETY CO., INC. for Section I - Raincoats and Section VI - Safety Boots; terms net, plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 10% of base year prices.
2. APOLLO INDUSTRIES for Section II - Rainhats; terms 2% 30 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 10% of base year prices.
3. BOSS MFG. COMPANY for Section III - Rainsuits and Section V - Hip Boots with straps; terms net, plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 5% of base year prices.
4. R.J. SAFETY SUPPLY CO. for Section VII - Rubber Boots, Over-shoe Type; terms net 30 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods, with price increases not to exceed 10% of base year prices.

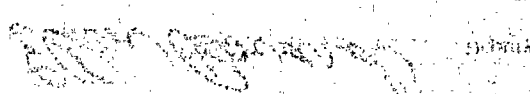
